Funding package

Thereafter the facility will become a medium-term loan that you will need to pay back over 18 months. You will get the unsecured overdraft facility at an interest rate of **prime plus 1%**.

- The latest financial statements and management accounts for your practice
- A statement of your assets and liabilities.
- A statement of your income and expenditure.
- Six months bank statements in the event you are not already a Nedbank client.
- Your payslip if applicable.
