

# SAMA MEDIA STATEMENT – RESPONSE TO THE 2023 BUDGET SPEECH

## **24 FEBRUARY 2023**

The South African Medical Association (SAMA) is concerned that the Budget Speech presented by the Minister of Finance, Mr Enoch Godongwana on 22 February 2023 was focused primarily on bailing out ailing State Owned Enterprises (SOE's) with little attention being paid to basic services such as education and health services, thereby further eroding section 27 constitutional rights for all in the country. Regarding the health sector the following was pronounced:

- R23 billion will be allocated to health, to cover the shortfall in compensation budgets
  and to improve services, which include hiring new staff, retaining health workers
  appointed during the pandemic and clearing the backlog.
- Revenue division: These allocations minimally alleviate the financial pressures, in health, where the costs of providing services continue to increase.

SAMA expected some specific pronouncements on the following:

- Safety and Security of medical professionals: Investment into the safety of healthcare workers due to the rise of crimes targeting healthcare workers countrywide.
- Compensation of medical professionals: Though the budget includes the hiring of new staff
  and compensation adjustments, SAMA waits to see how that will translate into reimbursing of
  our public service doctors.
- Load shedding impact and green energy proposals: There are only 77 out of 400 hospitals that are exempted from loadshedding, and many clinics are not exempted at all. Coupled with cable theft in some hospitals, the public healthcare system is in a state of disaster when it comes to the provision of electricity. Our members are not able to practice where operations are delayed or postponed. Poor, and indigent patients that visit public health facilities are the most disadvantaged in this context. The Ministry has yet to present proposals to invest in renewable energy in the public health facilities, bar the Centre for Science and Industrial Research (CSIR) feasibility study that was started in 2022.
- Infrastructure development of health facilities: SAMA notes that the Limpopo approved
  project is welcomed, but it is only a drop in the ocean. There are many facilities that are on
  their knees because of lack of medical equipment, lack of maintenance of medical equipment
  and other infrastructure support systems.
- Recruitment of Medical professionals: SAMA welcomes the additional budget to retain staff
  that were brought in during the pandemic. However more needs to be done to address
  unemployed medical professionals and placement of interns, community service doctors and
  those doctors who have completed their community service.
