## SAMA ICD-10 DOWNLOAD AND ACTIVATION

The SAMA ICD-10 is a Windows based program and requires the following operating system to run and install on:

- Windows XP / Vista / 7 / 8
- Window's .NET framework (will install automatically if not already on your computer)
- A valid SAMA licence activation key for the ICD-10 browser

The following steps will be clarified in this document:

- 1. How to buy the ICD-10
- 2. How to download the ICD-10
- 3. How to install the ICD-10
- 4. How to activate the ICD-10
- 5. Licence Terms and Conditions

#### Licence period:

The ICD-10 program has a one year licence period valid from 1 January to 31 December. Should you purchase the product within this allocated time period, the licence will only remain valid for the remainder of the above mentioned one year period. A grace period of two months will apply, thus the program will remain functional for January and February the following year.

#### Step 1: How to buy the ICD-10

- Refer to SAMA's sales process document on how to purchase a SAMA product online.
- After a successful online sales transaction you should have received an email from SAMA's website with your invoice and product details.
  - If you purchased with a credit card you will receive this immediately after the transaction was successful.
  - If you chose to pay SAMA by means of an electronic funds transfer (EFT) you will receive an email requesting you to make payment, before the system generates an invoice and the product details.

Should you not receive this email within 48 working hours after payment was made, please contact SAMA's Coding Unit at 012 481 2073.

### Step 2: How to download the ICD-10


- Open the email sent from SAMA to the email account as stated in the online sales process.
- You will note the words "If you purchased an electronic version of the ICD-10 you can install the program by <u>clicking here</u>"
- You will also note the Activation Key for each of the licenses bought, as indicated in the red box below.
- Before you download and install the Windows ICD-10 ensure that your computer complies with the set requirements to run the software.
- To download the program click on the link "<u>clicking here</u>", as indicated by the red circle on the left.




 Should you receive this error message, please click on the drop down arrow and select 'Keep". This message might display depending on the security of your internet browser.



Once the download is successful and complete you will see the "setup.exe" file.



You have now successfully downloaded the SAMA ICD-10. The next step is to install the program onto your computer.






## Step 3: How to install the ICD-10

 Once you have successfully downloaded the SAMA ICD-10, click on the "setup.exe" file which appear after the download is complete.



The following security Warning will pop up on your computer's desktop. This occurs because the program was not designed by Microsoft.




Click on "Run" to install the ICD-10.

### Additional step for some users

- Depending on the version of Windows running on your computer you might receive this "Microsoft .NET Framework 4" install screen. This is a driver that has to be installed on your computer before all SAMA's coding products can be installed. Newer versions of Windows might have this driver installed on purchase or with regular updates of Windows, thus not everyone will follow this step.
- Click on "Accept" to install the "Microsoft .NET Framework 4".











• The installing of Microsoft .NET Framework 4 should start automatically.



 To install the SAMA ICD-10 application this screen will appear once the .NET Framework has completed its install.




- Click on "Install" to install the program.



The program should open and display the following screen.




Refer back to the email sent to you from SAMA from where you downloaded the ICD-10.



**"SAMA"** means the South African Medical Association, a non-profit company, Registration Number: 1927/000136/08);



"**Purchaser**" means any individual, person, medical doctor, association of doctors, partnerships and incorporated practices and any employee of the medical practitioner, association, partnership, incorporated practice, medical scheme, medical scheme administrator, managed care organisation, independent practitioners association, hospital group, electronic billing service, training institution or any other firm or company who purchases the ICD-10 from SAMA.



- 1.3 At no time, shall any of the Intellectual Property Rights in the ICD-10 pass to or vest in any Purchaser.
- 1.4 The name "SAMA ", "WHO" and "ICD-10" and their logos and all related product and service names and slogans are the trademarks of SAMA and the World Health Organisation and may not be used in any way by any Purchaser, save with the prior written consent of the WHO and SAMA.







### 2. Purchaser obligations



- 2.4 The Purchaser shall, at no stage, acquire any right, title or interest in Third Party Material contained within the ICD-10.

### 3. General

- 3.1 These Terms and Conditions constitute the entire agreement between the parties in relation to the use of the ICD-10 and supersede any previous agreement or understanding between the parties.
- 3.2 Any notice required or permitted to be given by the Purchaser to SAMA under these Terms and Conditions shall be in writing addressed to SAMA at its registered office. Any notice required or permitted to be given by SAMA to the Purchaser under these Terms and Conditions shall be in writing addressed to the Purchaser at the address supplied in the purchase order.
- 3.3 No failure or delay by either party in exercising any of its rights under the Terms and Conditions shall be deemed to be a waiver of that right, and no waiver by either party of any breach of the Terms and Conditions by the other shall be considered as a waiver of any subsequent breach of the same or any other provision.
- 3.4 If any provision of these Terms and Conditions is held by any competent authority to be invalid or unenforceable in whole or in part, the validity of the other provisions of these Terms and Conditions, or the remainder of the provision in question, shall not be affected.
- 3.5 These Terms and Conditions shall be construed and governed in accordance with South African law and the law of the countries of third parties if applicable
